### Your Legacy to Kimbolton School

Your Will is one of the most important documents you will ever sign. It allows for the distribution of your estate (your wealth and possessions) according to your wishes after your death, enabling you to benefit family members, friends, and organisations of your choice. Some estates in the UK may be subject to inheritance tax; it may be possible to reduce the rate of inheritance tax applied to an estate by ensuring that a proportion of the estate is left to UK-registered charities. Kimbolton School is a Registered Charity in the UK, number 1098586.

Legacies (sometimes known as bequests) have benefited Kimbolton School many times over the years. Legacies can be for the general purposes of the school, or for specific purposes (e.g.: a bursary fund). If you plan to leave a legacy to Kimbolton School for anything other than general purposes, it would be helpful if you could please contact the Development Director to discuss how the school can enact your wishes.

The school's motto reads *spes durat avorum* – which translates as “the hope of our forefathers endures”. Leaving a legacy to Kimbolton School ensures that the hope of our founders – of education – does indeed endure!

### How to leave a legacy to Kimbolton School

We are grateful to all of those who remember Kimbolton School in their Will. A legacy gift can be written into a new Will, or added to an existing one using a codicil. We recommend that you consult legal advisers before drafting a new Will, updating an existing Will, or making other plans for your estate. A qualified legal advisor will ensure that your wishes are clearly expressed and that all the legal formalities have been correctly adhered to.

There are two main types of legacy gift that you can make under a Will:

- A gift of a specified sum of money (a “pecuniary bequest”). Such a sum of money can be indexed to preserve its value against inflation.
- A gift of a specific portion of your estate, once other considerations have been taken into account (a “residuary bequest”). You can choose to leave any proportion – it might be 1%, but it could be up to 100% – it all depends on your circumstances.

It is sometimes possible to leave gifts of property, or other assets to the school. It is also sometimes possible to add the school to an existing Will using a codicil form; if you are interested in either of these, please contact the Development Director for a confidential discussion.

The following wording may be used when adding Kimbolton School to a Will:

“I give to Kimbolton School (Registered Charity Number 1098586)

[ the residue of my estate]

free of tax for the general purposes of the school and I declare that the receipt by the Bursar or other authorised Officer of the school shall be good and sufficient discharge to my Executors.”
